RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT AND PARENTAL CONSENT

By signing this form and in consideration of participating in gymnastics & dance events, I, for myself and as the minor’s parent and/or legal guardian understand the nature of this activity and participation involves risks of serious bodily injury, including permanent injury, paralysis and death which may be caused by my or the participant(s) actions or by the negligence of the “releasees” named below; and that there may be other risks not known to me or foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, cost, and damages that I or other listed individuals incur as a result of participating in the activity. If we believe the event conditions to be unsafe, we will immediately discontinue participation in the activity.

I hereby release, discharge and covenant not to sue PRECISION ELITE GYMNASTICS ACADEMY, INC., its administrators, directors, officers, employees, volunteers, other participants, and if applicable, owners and lessors of premises on which the activity takes place, (each considered one of the “ releasees” herein) form all liability, claims, demands, losses, or damages on my account or alleged to be cause in whole or in part by the negligence of the “releasees” or otherwise, including negligent rescue and first aid and future agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on the minor’s behalf or on my behalf, makes a claim against any of the releasees, I will indemnify, save, and hold harmless each of the releasees from any loss, liability , litigation expenses, attorney fees, damage, or cost, which any may incur as the result of such claim.

I hereby release, discharge, covenant not to sue and AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS each of the releasees or otherwise, including negligent rescue operations, and further agree that if, despite this release, I, the minor, or anyone on the minor’s behalf or on my behalf makes a claim against any of the releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS each of the releasees from any loss, liability, damage, or cost, which may incur as the result of such claim.

Additional Policies: Photographs and Videos: I also give permission for photographs and videos of my child to be used in print or broadcast media or posted on the internet as deemed appropriate for the promotion of any Precision Elite Gymnastics Academy Inc. activities.

All children, including siblings & guests: must remain inside the Precision Elite building unless supervised by an adult. We cannot be responsible for children once they leave our building. Children are not allowed to wear jewelry into the gym Precision Elite will not be responsible for any lost jewelry or other personal items.

Dress Code: For the safety of the gymnasts and dancers, Precision Elite requires that all participants are dressed appropriately in leotards or shorts and t-shirts, hair pulled back and without socks for gymnastics & hip hop, leotards, tights and shoes for dance. Clothing with zippers, buttons, or snaps should be avoided as it can lead to injury.

Medical Emergencies: Consent to Emergency Medical Treatment/Medical Insurance: I confirm that my child is in good health and that I currently provide medical insurance for my child and will continue to provide medical insurance while he/she is enrolled in any programs provided by Precision Elite Gymnastics Academy Inc. I/We do hereby authorize any adult officer, director, supervisor, instructor or employee of Precision Elite Gymnastics Academy Inc. who has care and control of the student to consent to any medical treatment of the student when I/We cannot be contacted.
